Regulations passed in Parliament

1. The Imports and Exports (Control) Regulations No. 02 of 2025, published in the *Gazette Extraordinary* No. 2421/44 issued on January 31, 2025, allowing the importation of motor vehicles into Sri Lanka, were passed in Parliament on March 20, 2025.
2. The Imports and Exports (Control) Regulations No. 03 of 2025, published in the *Gazette Extraordinary* No. 2428/07 issued on March 19, 2025, regarding the submission of Export Inspection Certificates relating to the importation of motor vehicles, were passed in Parliament on May 22, 2025.
