IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with sub-section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act No. 48 of 1985 and Act, No. 28 of 1987, I, Mahinda Rajapaksa, the Minister of Finance promulgate following Regulations.

REGULATIONS

- 1. These Regulations may be cited as the Imports and Exports (Control) Regulations No. 08 of 2020.
- 2. The Regulations prescribed in this *Gazette* shall only be applicable to importation of goods which have the date of Bill of Lading/ Air Waybill on or after 19 October 2020.
- 3. The following items and their corresponding entries described in the **Schedule I** of the Imports and Exports (Control) Regulations No. 04 of 2020, published in the *Gazette Extraordinary* No. 2184/21 dated 16 July 2020 are hereby deleted from that Schedule and following items are included in to the **Schedule II** of the *Gazette*.
