IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-section 4(1), Section 6 and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Mahinda Rajapaksa, the Minister of Finance, promulgate following Regulations :

Regulations

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 04 of 2021**”.
2. No Bill of Entry (Customs Declaration / CUSDEC) shall be accepted on or after 07th April, 2021 for importation of goods listed out under the Regulation No. 3 in this *Gazette*.
3. The following items and its corresponding entries, shall be inserted into the **Schedule IV** of the Special Import License Regulations, published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017 as amended.

7. Import Control License fee, which shall be payable on the following goods, shall be inserted into the **Schedule I** of the Special Imports and Exports Control License fee, published in the *Gazette Extraordinary* No. 1953/28 dated 11 February 2016, as amended.
