Government Notifications

Imports and Exports (Control) Act, No. 1 of 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1), Section 14 of the Import and Exports (Control) Act, No. 1 of 1969, as amended by Act No. 48 of 1985 and Act No. 28 of 1987, I, Basil Rajapaksa, the Minister of Finance, promulgate following Regulations.

REGULATIONS

1. These Regulations may be cited as “**Imports and Exports (Control) Regulations No. 14 of 2021**”.
2. The Regulations prescribed in this *Gazette* shall only be applicable to the importation of goods which have the date of Bill of Lading/ Air Waybill on or after 03 November 2021.
3. Goods described below together with their corresponding entries shall be deleted from the **Schedule I** of the Imports and Exports Control Regulations No. 10 of 2021, published in the *Gazette Extraordinary* No. 2231/18 dated 11 June 2021.
