IMPORTS AND EXPORTS CONTROL ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Ranil Wickremesinghe, the Minister of Finance, Economic Stabilization and National Policies, promulgate following Regulations.

REGULATIONS

1. These Regulations may be cited as the “**Imports Control Regulations on Payment Terms No. 15 of 2022**”.
2. The Imports Control Regulations on Payment Terms No. 07 of 2022, published in the *Gazette Extraordinary* No. 2278/ 21 dated May 06, 2022 as amended is hereby further amended.

3. The date of arrival at Ports / Airports of essential food commodities imported on the recommendation of the Secretary, Ministry of Trade, Commerce and Food Security in terms of the Regulation No. 4 (d) of the Imports Control Regulations on Payment Terms No. 07 of 2022, as amended by the Imports Control Regulations on Payment Terms No. 10 of 2022 published in the *Gazette Extraordinary* No. 2285/19 dated June 24, 2022, shall be extended as follows;
 - i. Goods Specified under the **HS Codes of 0402.21.00 and 0713.40.11 of the Schedule I** to the Imports Control Regulations on Payment Terms No. 10 of 2022 as amended, shall be allowed to import under the Open Account/ Consignment Account payment terms subject to recommendation of the Secretary, Ministry of Trade, Commerce and Food Security, obtained prior to arrival of such goods to the Ports/ Airports of Sri Lanka on or before October 31, 2022.
 - ii. Goods specified in the **Schedule I to the said Regulations**, except goods referred in 3 (i) above, shall be allowed to import under the Open Account/ Consignment Account payment terms subject to recommendation of the Secretary, Ministry of Trade, Commerce and Food Security, obtained prior to arrival of such goods to the Ports/ Airports of Sri Lanka on or before September 30, 2022.
4. Importation of goods specified under the **HS Codes of 0402.21.00 and 0713.40.11 of the Schedule I** to the Imports Control Regulations on Payment Terms No. 10 of 2022 as amended, shall be exempted from the Regulation No. 6 of the Imports Control Regulations on Payment Terms No. 07 of 2022, published in the *Gazette Extraordinary* No. 2278/ 21 dated May 06, 2022.
5. Importation of **Maize (HS Code of 1005.90.00) and Soya Bean Meal (Hs Code of 2304.00.00)** by registered poultry feed manufacturers are hereby allowed under the Open Account/ Consignment Account payment term subject to recommendation of the Secretary, Ministry in charge of subject of Agriculture, obtained prior to arrival of such goods to the Ports / Airports of Sri Lanka on or before October 31, 2022 for the purpose of manufacturing of poultry feed.
6. The Director General, Sri Lanka Customs shall consult the Secretary, Ministry of Trade, Commerce and Food Security on any importation made in violation of the Regulation No. 3 above and the Secretary, Ministry in charge of subject of Agriculture on any importation made in violation of the Regulation No. 5 above.
