## PART I : SECTION (I) — GENERAL

### Government Notifications

IMPORTS AND EXPORTS CONTROL ACT, No. 1 OF 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4 (1) and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act, No. 48 of 1985 and Act, No. 28 of 1987, I, Anura Kumara Dissanayake, the Minister of Finance, Planning and Economic Development promulgate following Regulations.

### REGULATIONS

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 14 of 2024**”.
2. These Regulations are promulgated based on decision of the Cabinet of Ministers dated September 13, 2024 on the Memorandum No. 24/1945/604/208 dated September 12, 2024 titled, “Approval for removal of Temporary Suspension on Importation of Motor Vehicles”.



3. The Imports and Exports (Control) Regulations No. 02 of 2023, published in the *Gazette Extraordinary* No. 2312/78 dated January 01, 2023, as amended subsequently, is hereby further amended.

3.1 Goods, classified under the HS Codes together with their corresponding entries as described in the Schedule below, which is an integral part of these Regulations, shall be deleted from the **Schedule I** of the Imports and Exports (Control) Regulations No. 02 of 2023 referred above.

3.2 An **importer**, who is imported motor vehicle; classified under the HS Codes referred to in the Regulation No.3.1 above; for personal usage or trading purpose, shall register such motor vehicle in the name of the importer if imported that motor vehicle for his/her personal usage or in the name of buyer if such motor vehicle is imported for trading purpose within 90 days from the date of Bill of Entry (Customs Declaration – CUSDEC) of the said motor vehicle.

3.3 For the purpose of the Regulation No.3.2,

- (i) Any motor vehicles, imported by an importer for trading purpose shall not be registered in the name of such importer (In the name of the Company, or Owner(s) of the Company or Directors of the Company) and if registered on bona fide basis, the ownership of such motor vehicle(s) shall not be transferred to a third party within a period of 03 years from the date of registration,
- (ii) Director General of the Sri Lanka Customs shall ensure inclusion of the Number of this Gazette Notification in the Cage No.44 and the Cost-Insurance-Freight (CIF) value of the respective motor vehicle imported under the provisions of these Regulations in the Cage No.46 of the Customs Declaration (CUSDEC), and
- (iii) The Regulation No. 3.2 and 3.3 (i), (ii) shall not be applied for any non-motorized goods, classified under any HS Codes referred to in the Regulation No.3.1 above.

3.4 If an **importer** fails to register any motor vehicle(s), imported as per provisions of these Regulations, within the 90 days as specified in the Regulations No. 3.2 above, such importer shall be liable to pay a monthly late fee of 03%(Three) Percentage of the Cost-Insurance-Freight (CIF) value of the said motor vehicle(s), which will be computed non-compounded linearly to the Commissioner General of the Department of Motor Traffic at the time of registration of motor vehicles, where a maximum cap on the payment of the monthly late fee for such late registration is limited at 45%(Forty-five percentage) of the CIF value of respective motor vehicle. For the purpose this Regulation,

- (i) Commissioner General, Department of Motor Traffic shall not register any motor vehicle(s), classified under the HS Codes referred in the Regulation No.3.1 and imported as per the provisions of these Regulations beyond 90 days from the date of Customs Declaration without the payment of monthly late fee as specified above;
- (ii) **No** waiver of the payment of monthly late fee shall be granted under any circumstances; and
- (iii) Any number of late days less than 30 days shall also be considered as a calendar month.

3.5 Any importer, who is imported motor vehicles more than 25% of his or her total imported motor vehicles during a period of every six (06) months from the date of these Regulations until the end of December 2025 in violation of the provisions of the Regulation No.3.2 above, shall be suspended from importation of motor vehicles for a minimum period of thirty six (36) months under the provisions of these Regulations.

4. Age of a motor vehicle for the purpose of these Regulations shall mean the period between the Date of Manufacture (Mentioned either in the Manufacturer's Certificate or Export Inspection Certificate, specified in the Import and Export (Control) Regulation, No. 02 of 2013, published in the *Gazette Extraordinary* No. 1804/17 dated April 03, 2013) and

date of the Bill of Lading or Airway Bill of that motor vehicle. Non-motorized goods, specified under the HS Codes, referred in the Regulation No.3.1 shall mean only to the not used goods prior to importation of such goods into the country.

5. If any motor vehicle, specified in the Regulation No. 3.1 above, is imported in violation to these Regulations and/or any prevailing Rules and Regulations applicable on importation of motor vehicle(s), such motor vehicles(s) shall be re-exported by the respective importer within ninety (90) days from the date of the Bill of Entry (CUSDEC) with all associated costs borne by the said importer.
6. To achieve the objectives of these Regulations, the Controller General of Imports and Exports shall issue “Operational Instructions” to the Director General of Customs, licensed banks or any other relevant authorities.
7. The final decision shall be made by the Controller General of Imports and Exports on any issues arising in relation to these Regulations except the Regulation No. 5 above.
8. These Regulations shall enter into force with effect from December 18, 2024.
