## **Introduction**

The Department of Import and Export Control was established in 1969 by the Import and Export (Control) Act No. 01 of 1969 with the objective of controlling of imports and Exports of Sri Lanka. This department plays a major role in the economy of the country as a regulatory body which is responsible for the imports and exports being subjected to a license requirement. Prior to 1977, there were a lot of restrictions for import and exports which resulted in a heavy volume of work for the department. This year department completes 48 years of service to the nation.

Our mission has broadened in preparing import and export regulations and providing facilities to promote import and export. These activities are fulfilled in accordance with the mission such as considering National Security, Economy, Public Health and Environment. Standardization of import and export items is conducted to protect local industries, environment and people of the country. Money laundering is also controlled by implementing necessary policy frameworks together with the exchange control department.

Necessary steps have been taken to control or ban critical item that has harmful effect to the environment and public security according to the International Conventions such as Basel, Rotterdam and Stockholm's. Eg: during last year regulations were established to ban conventional plugs and sockets and introduced single standards for 13 amp plugs and sockets. World Customs Organization revises HS Codes once in every 4 years. According to that revision Revenue Protection Order published by Ministry of Finance and Import and Export Control Department amended and published list of items controlled for import and export.

Import and Export Control Department has completed preparation for new automated computerized system and online submission of application has been established to ensure providing efficient and effective service to the trade community. Fully automated license issuing process will be established in near future.

## **Vision**

To safe guard the community and environment for better future.

## **Mission**

“Implementation of import and export policy decisions taken by the government from time to time in relation to security, economy, public health and environment etc. of the country in accordance with the Import and Export Control Act No.1 of 1969”

## **Functions**

- Publish or make regulations required to implement government policies on import and export.
- Control of the importation and exportation of selected commodities or items subject to issuance of import and export licenses.
- Assist the Director General of the Customs and Banks pertaining matter on import and export control regulations.
- Issuing operational instructions related to import and export control regulations to the commercial banks.

## **Output**

- During the year 2017, the mission of the Department was accomplished by way of issuing 14,887 licenses for the benefit of the country and its economy, subject to the imports and export control.
- Regularization of import control by debits subsequent to the receipt of verification the goods were imported in compliance with the license.
- Granting licenses on the basis of foreign exchange not being spent on importation as per the import and export control policies.
- Giving necessary assistance to the Director General of the Customs and the Controller of Exchange in the event of noncompliance with import and export control regulations
- Issuance Operational guidelines pertaining to import and export control to the commercial bank.
- Collection of revenue amount of Rs. 1,487 million as license fee and crediting the amount to the Consolidated Fund.

## Staff

Following permanent staff of the department served to carry out the administrative functions, i.e. issuance of import and export licenses, debiting, and collection of revenue and for activities related to policy planning as well. (Table I)

The staff committed collectively with responsibility to accomplish services of the Department of Import and Export Control at optimal level while providing effective and efficient service to the clients in friendly manner.

**Regulation on imposition of Import Control License requirement for Concrete Pump Trucks which are more than ten years old**

As per the letter No.TIP/TP/01/12(8) dated 22<sup>nd</sup> February 2017 by Ministry of Finance, Revenue Protection Order 2/2017(Extraordinary Gazette Notification No. 2006/42 dated 16<sup>th</sup> February 2017) import regulations of Concrete Pump Trucks has been amended. Under the above Revenue Protection Order, two H.S Codes have been created to cover,

- 8705.90.31 for the Concrete Pump Trucks which are not more than ten years old

- 8705.90.32 for the Concrete Pump Trucks which are more than ten years old

Further, it has been recommended to bring the H.S Sub Code 8705.90.32 under the Import and Export Control License requirement in order to manage the importation of Concrete Pump Trucks more than ten years old. Before introduction of new H.S Sub headings, the Concrete Pump Truck was categorized commonly under H.S Code 8705.90(Other).

Since, construction activities represent the second largest industrial segment of Sri Lanka. There are economical and social benefits to the country which can be gained by facilitating the construction industry. As requested by the Construction Industries two new H.S Sub Codes have been introduced and H.S. Code 8705.90.32 has been recommended to bring under the Import Control License requirement. This will regulate the proper importation of Concrete Pump Trucks and eventually contribute to boom the construction industry of Sri Lanka.

Therefore, in order to regulate the importation of the Concrete Pump Trucks which are more than ten years old, H.S. Code 8705.90.32 has been included in the list of items which require the ICL.

The Extraordinary Gazette No.2019/24 dated 19.05.2017 has been published in order to execute the proposals mentioned above and has been approved by the Parliament on 20<sup>th</sup> June, 2017

## **Regulation on imposition of Import Control License requirement and standard for Plugs and Socket outlets**

Section 4(1) (e) of the Sri Lanka Electricity Act No. 20 of 2009, requires the Public Utilities Commission of Sri Lanka (PUCSL) to discharge its functions under the Act in a manner which it considers is best calculated to protect the public from dangers arising from the generation, transmission, distribution, supply or use of electricity.

In 2012, reported deaths by accidental electrocution in Sri Lanka were 180, eleven times the international index, to contain by accidental electrocution to at most 20 persons in 2020. The use of numerous types of plugs, sockets, and substandard electrical equipment, adaptors and extension cords have been identified as a prime cause of electrocutions and fires. The plug attached to the appliances rarely matches with the socket, causing inconvenience to the public and a safety hazard by the use of substandard adaptors.

As per the recommendation from Public Utilities Commission of Sri Lanka (PUCSL), Economic, technical and safety regulator of the electricity industry, and steering committee Cabinet decision was taken on 16<sup>th</sup> August 2016 to standardize the plug and sockets in Sri Lanka. Type G, 13 A plug and socket outlet (Rectangular pin plug and socket) was adopted as the single standard of plugs and socket outlet in Sri Lanka.

Following timeline was approved by the cabinet in order to make the transition to the single standard more convenient to every stakeholder.

- I. Adopting the Type G (13 ampere plug and socket) as the unique and single standard for plugs and sockets in Sri Lanka
- II. Allowing a period of one year from 16<sup>th</sup> August 2016, import or manufacture of plugs, sockets, substandard multi-sockets and extension cords, and appliance carrying plugs other than type G would not be allowed from 16<sup>th</sup> August 2017.
- III. Allowing a period of two years from 16<sup>th</sup> August 2016, the sale of plugs, sockets, substandard multi-sockets and extension cords, and appliance carrying plugs other than type G would not be allowed from 16<sup>th</sup> August 2018.
- IV. Existing wiring, as well as plug and sockets presently used or sold within two years from the date of approval, will be allowed to remain in service, until the end of their useful life.
- V. Existing wiring, as well as plug and sockets to be until the end of their useful life, to encourage manufactures to provide in the market,
  - a) A specially marked Type G socket, as a replacement for any five ampere socket that needs replacement
  - b) Adaptor to enable five ampere plugs to be connected to 13 ampere sockets and vice versa
  - c) Extension cords confirming to standards

The amendment of Import (Standard and Quality Control) regulation solely cannot restrict the import of substandard 13A plugs, sockets, adaptors and extension cords. Further, shaver sockets, universal sockets and travel adaptor allowed to be used in hotels and for sale in travel shops. Hence, those items are allowed to import under the supervision of Public Utilities Commission of Sri Lanka (PUCSL) via Import Control License scheme.

Extraordinary Gazette No.2032/10 dated 15.08.2017 has been published in order to execute the proposals mentioned above and approved by the Parliament on 22<sup>nd</sup> September 2017.

### **Regulation on Import Control License Fee for imposition of Tea for Re-export**

Prior to import tea for re-export, an Importer is required to obtain approval from Tea Board to apply for an Import Control License for importation of tea for re-export purpose. For obtaining the approval from Tea Board, a fee of Rs.500.00 for an application as well as a payment of Rs.5.00 per kilogram of tea to be imported have to be made. Subsequently, Import License from Imports and Exports Control Department should be obtained on payment of a fee of 1% of CIF value. The relevant consignment of tea will be released by the Sri Lanka Customs on submission of both aforementioned approvals.

In order to facilitate the tea industry, particularly re-exportation of tea, it has been proposed to abolish the Import Control License Fee of 1% of CIF value on importer of tea for re-export purposes in the Budget 2017. Accordingly Ministry of Plantation Industries and Ministry of Development Strategies and International Trade, on request of the tea importers, submitted a joint Cabinet Paper No.17/1123/726/027 of 30.05.2017 to rescind and amend the item of Serial No.46 of the Schedule No1 stipulated in the Extraordinary Gazette No.1953/28 of 11/02/2016 issued in terms of provisions of the Imports and Exports Control Act, No.1 of 1969 in order to abolish the Import Control License Fee of 1% of CIF value on import of tea for re-export basis and charge Rs.1000.00 as nominal fee. This proposal was approved by the Cabinet of Ministers on 28.06.2017.

Accordingly, Extraordinary Gazette No.2039/4 dated 02.10.2017 has been published in order to execute the proposals mentioned above and approved by the Parliament on 20<sup>th</sup> November, 2017



### **Regulation on Import and Export Control License and Banned Items and Regulation on Export Control License Items**

Sri Lanka is a signatory body to the World Customs Organization (WCO) since 1968 and hence it is obligatory to implement the international convention on Harmonized commodity Description and Coding System. As per the Article 3 of the said convention the customs tariff and the statistical nomenclatures shall be in conformity with Harmonized System.

Harmonized System is reformed once in every four years. Accordingly, Harmonized System-2012 had been amended as Harmonized System-2017. The Customs Co-operation Council of WCO has recommended certain amendments to the existing Harmonized Codes in six (6) digit levels and introduced sixth amendment to the Harmonized System-2012. It is adopted as new version (2017) to ensure the keeping Harmonized System (H.S) up to date in the light of the changes in technology and patterns of International Trade. These amendments have been done by covering the agricultural sector, chemical sector wood sector, textile sector, base metal sector, machinery sector, transport sector and few other sectors.

Sri Lanka made amendments to the existing National Harmonized System in eight digit level to comply with the obligations of the WCO. Those amendments had been published through the Revenue Protection Order (RPO) as per the Article 3 of the International Convention on Harmonized Commodity Description and Coding System.

At the same time it is necessary to amend and publish all the regulations published in gazette notifications up to now which include amended HS codes by using new RPO without adding any new items. As per that requirement, following Extraordinary Gazettes are hereby repealed.

Schedule (IV) of the Extraordinary Gazette Notification No.1813/14 of 05<sup>th</sup> June 2013, 1882/40 of 02<sup>nd</sup> October 2014 and 1918/22 of 11<sup>th</sup> June 2015 has been amended by adding new banned items to it. All these newly added chemicals which come under the control of Montreal Protocol previously were in the control items list of said gazettes. But with the phase out scheduled chemicals of the Montreal Protocol, chemicals in the Annex B group I, Annex C group II and III had been included to the Banned List.

Accordingly, Extraordinary Gazette No.2044/40 and 2044/41 dated 09.11.2017 have been published in order to execute the proposals mentioned above and approved by the Parliament on 11<sup>th</sup> December 2017.

### Revenue Analysis - 2017

Estimated revenue for the year 2017 was Rs. 1200 million, and revised in July for Rs. 1350 million. The Department was able to earn revenue of Rs. 1487 million in the year 2017. The Revenue has increased by 35.18% compared to the year 2016 and it can be classified as follows.

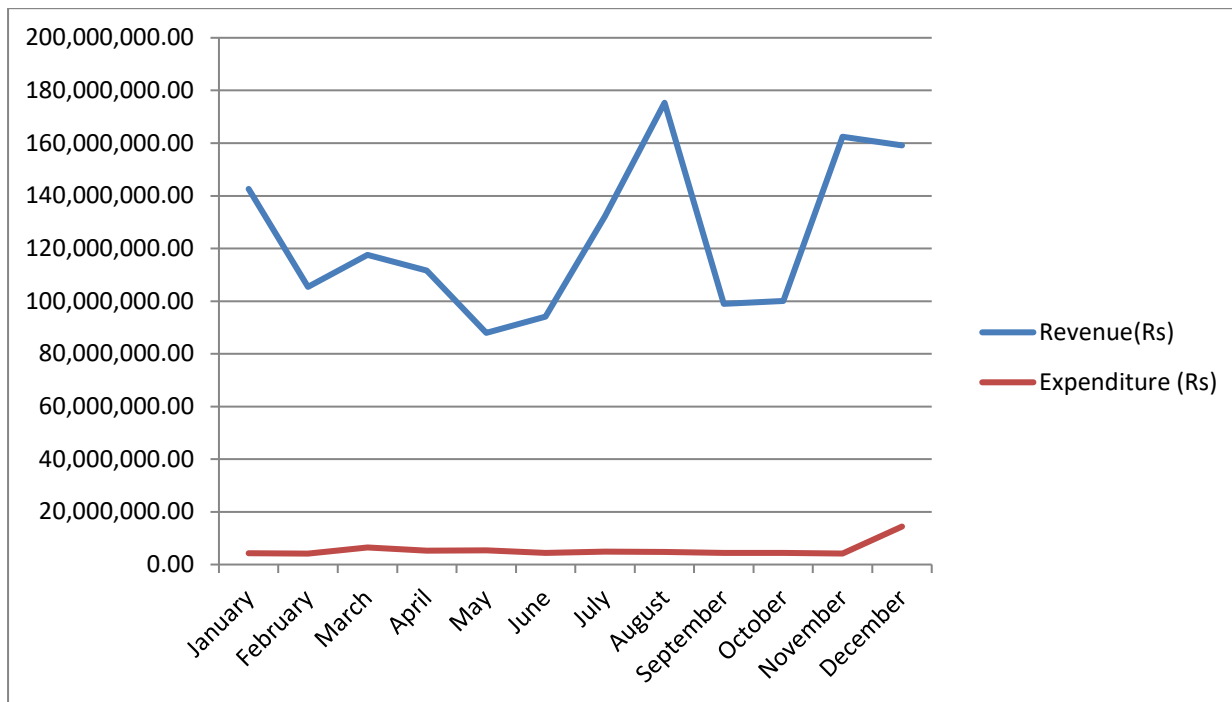

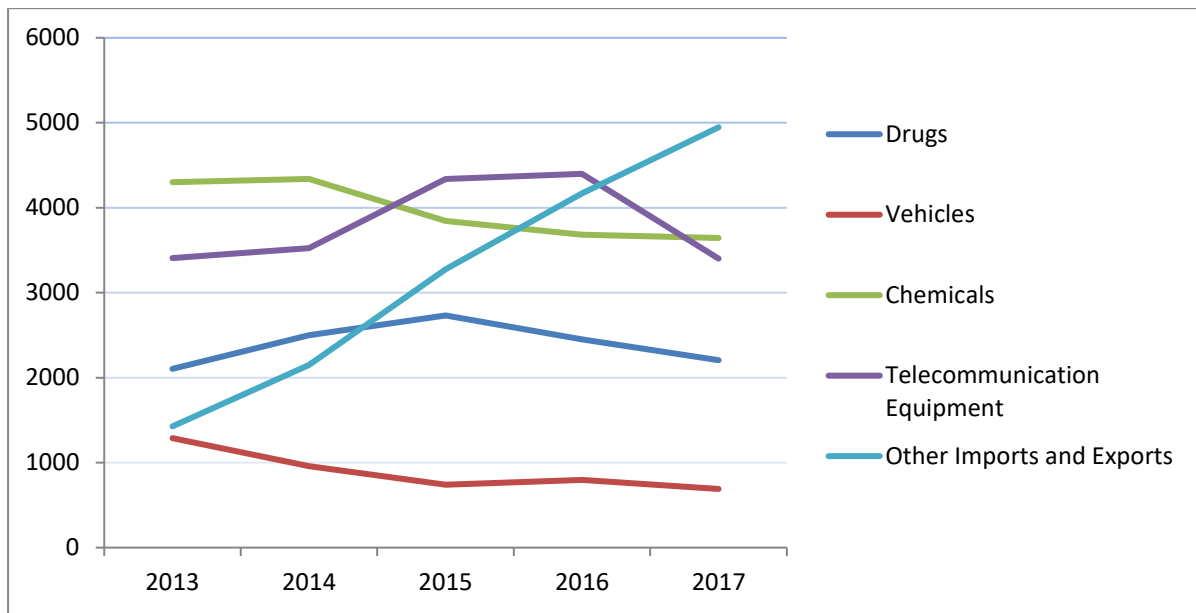

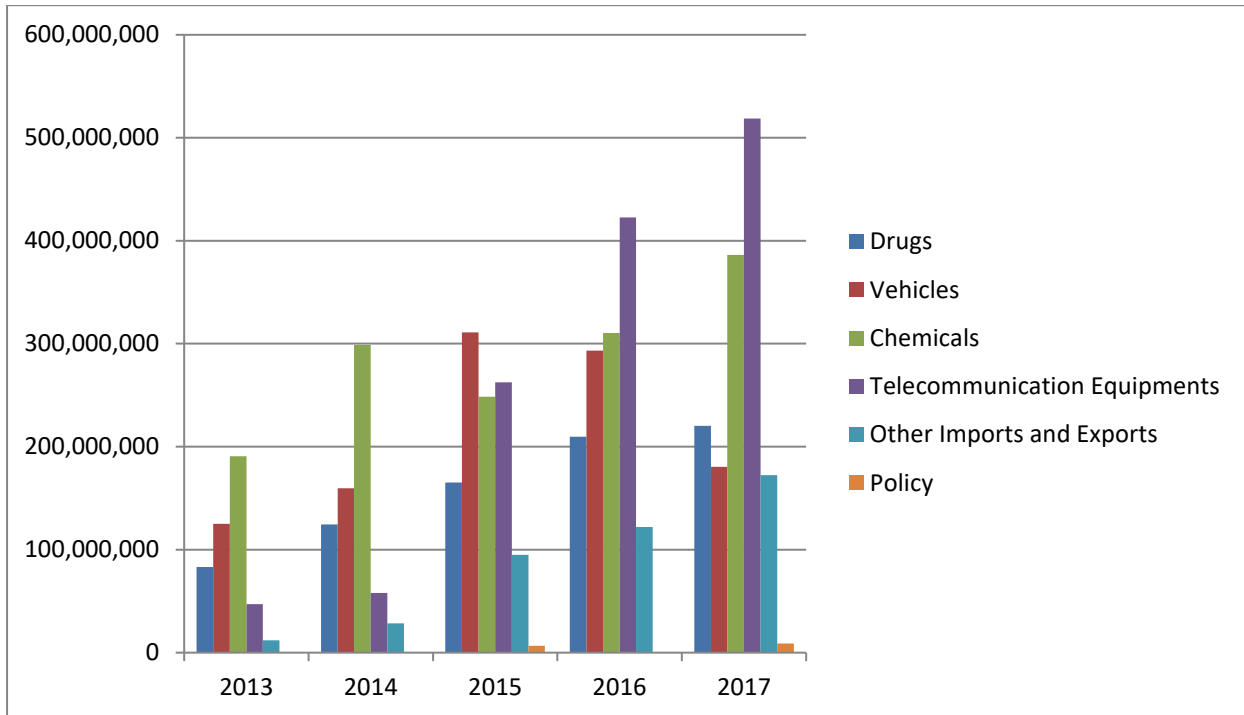

### Review of income and license data during last 5 years

Number of license issued during the last 5 years by the respective units is shown above.

#### Drugs – Unit 1

Even though, Number of license issued to import of drugs has been slightly gone down, income has gone up. Western Drugs are most part of the income and licence issued in Unit 1. Depreciation of rupee value and increasing the value of bulk licence might be reason for increase the income of the license.

#### Vehicle – Unit 2

Even if the number of license issued to import used vehicles went down during the year 2015, slight increase can be observed in year 2016, but in 2017 it is observed little decrease number of licence issued and the income generated.

**Chemical – Unit 3**

Highest number of license issued and income generated for import of chemicals recorded in 2014, but during last 3 years number of license issued have gone down continuously. But income has gone up continuously due to rupee depreciation. Petroleum products are the main part of chemicals and it is used for production processors in the country. During last 3 years production sector of the economy shown less expansion and it affects the drop of chemicals imports.

**Telecommunication Equipment and other – Unit 4**

Telecommunication equipment have been recorded rapid increase issuing number of licences and generated increasing income. Mobile phone import is the main component among importation of telecommunication equipment. During the year 2016 and 2017 telecommunication sector has recorded expansion and several massive projects have been implemented during those two years.

**Other Imports and Exports – Unit 5**

Continuous increase in number of license and the income are observed in unit 5. Animal Products are the most imported product during year 2017. It shows that animal food sector has been developed during the last year

**Policy Division**

Main activity of this division is to sort out the import and export related problems and make policy decision according to the import and export Control act no 1 of 1969.

Base on above act, this division prepare gazette notification and forward to parliament for approval

Apart from that, this division provide necessary instructions to the commercial banks and Sri Lanka Customs when there are discrepancies incurred while doing import and export activities by business community

According to the periodical policy changes made by government, policy division issue the Operating Instruction to the Commercial Banks and relevant authorities
